
### **Site Characterization Project Management and Integration Concept**




M&O's Role In Site Characterization

## Participant Roles in Yucca Mountain Site Characterization Project






### M&O Role in Issue Resolution What is Issue Resolution?

Issue resolution is the process of interaction or negotiation between DOE and NRC regarding technical or programmatic concerns to allow the licensing process to move forward for the MGDS


### **Issue Resolution and Annotated Outline** Organization for the MGDS








#### **Nevada Site M&O Organization**
